Baker, Adele Baker & family from any and all claims or liability of whatever nature including but not limited to claims for property damage, theft, health care or loss, personal injury, disability, death, pain, suffering and mental anguish, damage, claims for damage, injury, disability, pain, suffering, theft or health care related to any horse or other animal, whether now existing or hereafter arising, in any way connected with the use and enjoyment of Baker Farms or its facilities, connected with any horse riding instruction provided at Baker Farms, or connected with any Baker Farms facilities used outside of baker Farms, including horse trailers or other transportation.

This release shall bind the undersigned, their heirs, representatives, assigns, guests or anyone brought onto the land by the undersigned and shall inure to the benefit of Baker Farms, James P. Baker, Adele Baker & family, heirs, representatives, assigns, guests and insurers.

The undersigned acknowledges that he/she has read this release and understands the terms used in it and the legal significance of these terms. The undersigned acknowledges that he/she is signing this release voluntarily, and has been presented with a list of rules and regulations which he/she agrees to observe and follow at all times without supervision or reminder by Baker Farms.
